There are also administrative files of the AEA and its subgroups, particularly the Committee on the Status of Women in the Economics Profession (CSWEP). There are 50 black-and-white photographs of former AEA presidents, a 39x10 inch black-and-white group photograph taken at an unidentified meeting, 48 rolls of microfilm from various journals (mostly AER), 63 microfiche of JEL correspondence ([1968]-1980), seven reel-to-reel audiotapes, 16 floppy disks (most from CSWEP), and three optical discs and one logical file folder with membership directories.
