Scope and Content

Chiefly diaries but also includes correspondence, other writings and speeches, printed material, memoranda, photocopies of clippings, financial and genealogical papers, and family photographs. The collection principally relates to Newton's career as a politician and attorney as described in his extensive diaries, 1907-1984. He ran unsuccessfully as a Democrat to the U.S.

House of Representatives, 8th District, N.C. in 1938, 1940, and 1942. He also unsuccessfully ran for the Democratic nomination for the U.S. Senate in 1944.

Biographical/Historical

Giles Yeomans Newton was a North Carolina politician and attorney.
