### **Scope and Content**

The collection contains correspondence, memoranda, research, and reports related to the Pulpit and Pew research project; Forum on Excellence/Advancing

Pastoral Excellence Initiative project; Duke Youth Academy; and the website for national Sustaining Pastoral Excellence projects.

## **Biographical/Historical**

Leadership Education at Duke Divinity (LEDD) provides educational services, intellectual resources, and facilitates networks of institutions influencing Christian institutional leadership. Founded by a grant from the Lilly Endowment Inc. in 2008, LEDD is part of the Duke Divinity School and offers programs and grants for Christian leaders.

The Pulpit & Pew was a research project designed to describe the state of Protestant and Catholic pastoral leadership in the U.S. The project examined trends facing clergy and aimed to provide resources for pastoral leadership.

The Duke Divinity School coordinated the Sustaining Pastoral Excellence program under the Advancing Pastoral Excellence initiative. In May of 2005, it hosted a major Forum on Excellence in Ministry in Indianapolis, which brought together 250 leaders from a variety of churches and church-related settings.

The Duke Youth Academy was designed as a year-long program for young people to explore Christian life. The week-long residency on the Duke University campus was combined with a year of mentorship, practice, and online community.

The website for Sustaining Pastoral Excellence projects served as a forum for articles and nationwide projects nationwide from 2005 to 2008, when publication ceased.

The Institute for Clergy Excellence was funded by the Lilly Endowment for the Duke Divinity School to host a coordination program enabling grantees to connect with and learn from one another.
